



Financial gap - estimate

£ millions	2023/24	2024/25	2025/26	2026/27
Current MTFS Gap	8	24	40	40
Estimated Increase	21	54	65	95
Potential Gap	29	78	105	135
Existing Savings	13	23	32	32
Total Challenge	42	101	137	167

Closing financial gaps has become business as usual

BUT

- Austerity was £230m in 12 years
- Facing c.£170m in 4 years





Emerging pressures – 2023/24

Pay awards ~ +£14m

+

National Living Wage ~ +£8m

+

Contract Inflation ~ +£9m



Adult Social Care reform ~+£5m

On top of ongoing pressures:

significant growth in demand

shortages of core skills/resources



Criteria for Member decision making on service reductions

- Statutory or discretionary provision or service
- National or local access criteria
- Impact on vulnerable individuals and communities/EDI impacts
- Consultation feedback
- Scale of potential saving
- Ease of implementation/delivery timescales
- Political pledges/commitment to implement
- Impact on Strategic Plan priorities
- Reputational risks

Medium Term Financial Strategy approach

Savings

- Urgent progress needed on delivering existing savings (including earlier)
- Focus on new savings that can be delivered in short time scale
- Proposals for service reductions for Member decision making

Spend controls

In-year and forecast position necessitates introduction

Growth

Unavoidable only

Capital

2-year moratorium on additional so restrict to invest to save, end of life or fully funded

Reserves


Further assessment of reserve balances and use





Consultation
